




COMMUNITY SURVEY RESULTS

- Kicked off during COVID
- City led outreach with robust social media, yard signs, and newsletters
- **Paper copies** were made available at City Hall
- Open from May 25th to August 10th
- 2,218 participants

SURVEY RESULTS: VALUES

We asked: "What do you value most about living in University Park? Select up to three."



- Connectedness and sense of community

SURVEY RESULTS: WHAT CITIZENS WANT

We asked: "What would you like to see more of in University Park? Check all that apply.

- Greater enforcement of on-street parking regulations More circle driveways to get parked vehicles off streets Additional parking in commercial areas **Retail Stores** Restaurants and entertainment Mixed-use development Rules preserving trees on private property Rules preserving trees on public property More central channels of communication Collaboration with SMU


Parking, retail/restaurant options and tree preservation are highly valued

More than half of residents are willing to pay more for certain services




SURVEY RESULTS: REDEVELOPMENT

- More multi-family units; apartments, townhouses, and condominiums






5 - Least Important

We asked: "In 30 years, where would you like to see the City of University Park?."






A majority of residents are pleased with the City as it is now, mostly residential





LESSONS LEARNED AND DIRECTION FROM THE COMMUNITY

- Most raised issues were transportation, traffic and parking for drivers, walkability/connectivity and safety concerns for pedestrians and cyclists
- Other frequently raised issues were related to aesthetics - concerns about new buildings not meeting standards, as well as a desire to conceal utility lines

DEVELOPING THE PLAN

- Master Plan Committee brought in 80+ citizen volunteers to work in 10 Focus Groups
- Intensive meetings were held throughout spring and summer
- Each Focus Group had support from planning team and City staff
- Developed **127 specific goals** for the plan ${ \bullet }$
- Staff review and multiple rounds of MPC review cut and condensed the priorities to **75 goals organized into 5 Themes**

5 THEMES

- **1. AFFIRMING SENSE OF PLACE**
- **2. ASSURING CONNECTIVITY**
- 3. INNOVATIVE GOVERNANCE
- 4. TECHNOLOGICAL INTEGRATION
- **5. PREPARING FOR THE FUTURE**

THEME: AFFIRMING SENSE OF PLACE

Sample Goals:

- Establish tree ordinance to protect mature and healthy trees
- Explore opportunities to bury utility lines (where feasible)
- Update security protocols for City facilities while maintaining welcoming atmosphere

Sample Goals:

- Develop a comprehensive, multi-faceted approach to parking management using future-focused technology
- Park Connectivity Program for Trails

Sample Goals:

- Create a civic foundation to allow for resident-led funding of City departments or projects


THEME: TECHNOLOGICAL INTEGRATION

- Work with city IT department to continually upgrade security of city computer systems, and develop a model program to test roundabout viability as a way to reduce congestion

THEME: PREPARING FOR THE FUTURE


Sample Goals:

- Maintain the look and feel of the entirety of University Park 4.
- Hire a University Park Police Department Officer who will Focus on Mitigating the Devastating Effects that 5. Substance Abuse can have on the University Park Community
- 6. Use technologies such as Surveillance Cameras and License Plate Readers to Support Public Safety in Investigating, and Resolving Accidents at Signalized Intersections
- 7. Harvest Rainwater and Runoff Water Collected in Underground Storage Tanks at Caruth Park for Irrigation of City Parks and Playing Fields
